Special: Graham Avery – A dream in Prague

On 4 December 2008, on the occasion of a dinner in Prague during the Pre-Presidency Conference organised by the Czech Institute of International Relations, TEPSA's Chairperson Wolfgang Wessels thanked the outgoing Secretary General Graham Avery for his work, and presented him with a gift to mark the appreciation of the association. In reply Graham thanked the colleagues in TEPSA for their cooperation – the member institutes, the members of the Board, and the colleagues in the secretariat – and he concluded by relating the following dream.

After going to sleep in my hotel in Prague last night I woke to find myself in the same hotel, but in a different Prague. As I walked in the streets I saw new buildings all around me, many green spaces, and not so many tourists. It was very confusing. But then a beautiful young woman approached me, took me by the arm, and said "you must be a grandson of Graham Avery – I recognise your face from the photographs which I have seen of him – he was one of the participants in the famous conference of TEPSA in Prague 100 years ago".

Now I was even more confused, but she was a very charming person, so I sat down next to her and said "please help me, I just came from another part of the world and I want to know what is happening here in the centre of Europe. How is the European Union? Does it still exist?"

"Well" she replied "it does exist, but we prefer to call it the European Community, we think that's a better name. Let me tell you some of the things which have happened to it.

First, we finished with enlargement. In 2015 Croatia joined us, and after decades of negotiation we finally admitted Turkey. For some years it was the biggest member state, with 85 million people, but then in the middle of the 21st century our Russian friends applied for membership — their population had declined by then to 100 million people — so we admitted them too — that was when Yevgeny Moshes was President of Russia.

Now we have more than 40 member states, and each widening has led to a new deepening of the European Community. Our main partner is China, and we are discussing with the Chinese how to handle the latest international crisis: now that California has declared independence, Alaska and other states may follow, so the United States – I mean the United States of America – may soon cease to exist.

Second. finished with the debate we. Euroscepticism. The Irish and the British had to leave us because they couldn't ratify the treaty which was signed at Bucharest in 2019. The Czechs tried to follow them, but they were obliged to stay in because couldn't get a constitutional majority in Parliament to leave the European club. Then, after 5 years in the wilderness, the British and the Irish applied for membership, so we let them in again, together with the Norwegians. This turn of events was salutary, and now we have a more rational debate about European affairs.

Finally, we finished with the Trans European Policy Studies Association, which was taken into a new organisation. Let me explain what happened. TEPSA's member institutes succeeded so well in their mission of defining the way ahead for Europe, by analysing the interface between national and supranational interests, that the member governments listened to them more and more, and they became known as the 'Tepsocrats'.

Then we had the constitutional crisis of the 2080s, when the European Commission was sacked three times by the European Parliament, half of the employees of the Commission went to work for the College of Europe, and the Belgian state converted the Berlaymont building into a museum. So the Council and the Parliament had to find a new solution for the governance of Europe, and they decided to invite the members of TEPSA to become the Trans European Policy Executive – TEPEX, as we call it – with the task of formulating proposals to the European institutions in the European interest.

TEPEX decided to have its seat of operations in Prague, so now in their offices up there in the historic Cernin Palace you can see the gallery of honour with photos of all the persons who took part in the historic TEPSA conference here in 2008. That is how I recognised you, Mr Avery, as a descendant of one of those famous visionaries "

As you can imagine, as I listened to her explanation of these events, I became really excited, so I turned to embrace her ... and then I woke from my sleep.

Friends and colleagues, it was good to share this dream with you, and I hope that you will make it come true!

TEPSA welcomes new member institute in Malta

At the General Assembly in Prague on 5 December 2008 TEPSA approved the membership of the European Documentation and Research Centre at the University of Malta (EDRC). EDRC was established in 1992 and In 2004 was awarded the title of Jean Monnet European Centre of Excellence following years of achievement in

Jean Monnet Projects. These projects are open to centres specialised in European affairs under the European Union's Jean Monnet Programme.

The EDRC has followed and follows projects like the Civil Society Project, the MESA Project, the Annual EDRC Conference, the Dialogue Project (2006-2007) and the EU-Med Project (2002-2004). Furthermore, it offers courses in European Studies at the University of Malta and hosts the European Documentation Centre (EDC). The Director of the EDRC is Prof. Roderick Pace.

Jean-Victor Louis, a member of TEPSA Board, is emeritus professor, Université Libre de Bruxelles (ULB) (2003-), a former president of the Institute of European Studies of the ULB (1980-1992), a former part time Professor, European University Institute, Florence (1998-2003) and dr.

h. c., University of Paris II (2001). He is also honorary general counsel, National Bank of Belgium (1980-1998). He was president of the Groupe d'études politiques européennes (GEPE/SEP), the Belgian TEPSA member up to its liquidation in 2007.

He chairs the Foundation Philippe Wiener- Maurice Anspach, a charity under Belgian law in charge of promoting scientific relations between the University of Brussels (ULB) and the Universities of Oxford and Cambridge. He is the general editor of the Cahiers de droit européen, published since 1965, and he is a member of European Constitutional Law Network (ECLN) and of the Committee of international monetary law of the International Law Association (ILA).

Carlos Rubens appointed treasurer

Belgian central bank, worked in different departments (foreign exchange markets supervision, central balance sheet office, legal department). Conference: The French Presidency – a transforming moment for the EU?

Centre d'études et de recherches internationales, Sciences Po, Paris

In the framework of the THESEUS project and in cooperation with the Centre d'études et de recherches internationales (CERI) TEPSA as partner within THESEUS will bring together researchers and key politicians in Paris. The conference will address the question, whether the French Presidency constitutes a transforming moment, a moment of change in the development of the European Union, given the fact that the Irish "No", the summer war in Georgia and the financial crisis occurred within this timeframe, demanding for reactions and actions from the European side. At the same time the priorities set by the French Presidency beforehand in the areas of migration. CFSP, energy-, climate- agricultural policy had to be addressed. Thus it is necessary to analyse whether during the French Presidency a new role of the EU in the international system has been assumed.

The conference will involve researchers from multiple disciplines and include as speakers among others Wolfgang Wessels, Hubert Védrine and Lenka Rovna.

EU-CONSENT Workshop on "The present and future of national legislatures in EU Governance"



The European Institute of Public Administration (Maastricht) and the Federal Trust for Education and

Research (London), in co-operation with TEPSA, are organising a workshop on the present and future of national legislatures in EU governance at the Fondation Universitaire in Brussels on 28 April 2009.

The aim of the workshop is to bring together academics and practitioners to discuss about the recent evolution and the future challenges of the role of the national parliaments in the EU decision-making process, especially in view of the most recent enlargement of the Union and the changes envisaged in the Lisbon Treaty.

We will count on contributions by some members of the European and national parliaments, a representative from COSAC secretariat and other experts in the field. In addition, we would like to invite other scholars working on the topic, especially on the following issues:

- What are the challenges for the implementation of the changes envisaged in the Lisbon Treaty; to what extent may they have a real impact on the current situation?
- What added value can EU inter-parliamentary cooperation bring to the work of national legislatures and what channels are used for the cooperation? Do there exist other contacts with the European level and MEPs?
- What are the main changes in the new Member States after accession?
- What is the assessment of the reporting, document based scrutiny or mandating systems? In which ways has it been affected by the 'europeanization' of the organizational procedures? Are there any differences across policies and pillars?
- Are there incentives and strategies for MPs to get involved in EU affairs? To which extent is the role of national parliaments moving from reactive scrutiny to proactive European work? Are relevant proceedings of domestic co-ordination open to national parliaments?
- How may all these developments contribute to the improvement of the EU democratic deficit?

EKEME roundtable discussion "Are we late? Evaluation and perspectives of the reforms in Greece and in Europe"

In the framework of its General Assembly, the Greek Centre of European Studies and Research (EKEME) organized a roundtable discussion under the heading "Are we late? Evaluation and perspectives of the reforms in Greece and in Europe" on 31st October 2008, at the Office of the European Parliament in Athens. Professor Panos Kazakos was moderator of the discussion.

The discussants tried to answer the following questions: Should the reforms in Greece continue and how? What do we expect from the reforms?

First, the reform procedure from 1996 until now was evaluated by the top-class speakers, followed by a discussion on the Lisbon Strategy as a learning process. Furthermore, speakers dealt with the financial system, the National Strategic Reference Framework and the prevailing "democratic inertia" in Greece.

Issues of specific reforms in the public administration were also raised, such as the strengthening of the positions of Secretaries General and of Directors General. In addition, regarding the political procedure, the reform of the electoral system was also suggested.
