## **Towards a two-speed Europe?**

*The last summits of the Eurogroup and the European Council of 9-10 December paved the way for a new start in the debate on a two-speed Europe. Both President Sarkozy and Chancellor Merkel envisaged the settling of a Europe composed of a core group around the eurozone within a Europe of twenty-seven. The meeting ended up with the decision to conclude an intergovernmental agreement in which the United Kingdom will not take part. In an article published on 4 November 2011 entitled "Save Europe, divide Europe," the former legal counsel of the Council Jean-Claude Piris, favored openly a two-speed Europe. It would be set up either in a smooth manner with the use of exemption clauses offered by the treaties, or with the conclusion of a treaty compatible with the Lisbon Treaty in which eurozone members would set up a closer cooperation managed by specific institutions with a separate executive commission and a parliamentary assembly representing national parliaments.*

*These views haven't received unanimous backing. Member states not participating in the eurozone are reluctant. They feel closely involved in the structuring of a zone in which treaties require them to participate once they would meet the requirements. They are currently considered as members "with derogation". One needs to be moderate however. The position of those who accepted the 'euro-plus' pact is different from those who put themselves on the sidelines. The attitude of United Kingdom is similar but less understandable. It confirms not wanting to adopt the euro but at the same time claiming a right of inspection with no obligation of solidarity. The United Kingdom is a prisoner of choices: not participating in some policies while suffering from those consequences. Prime Minister David Cameron claims to regain a number of competences back to the United Kingdom notably social ones. He wants the Union to become a "network" essentially centered around the internal market. This hasn't prevented the UK from wanting to be the spokesman of the "outs". Although isolated they strongly favored solidarity between EU members. For its part, the President of the Commission whose authority has been oddly reduced with the creation of the European Council Presidency and the European Council's role in managing the crisis, does not seem to favor the formation of a "euro" group being the basis of a two-speed Europe.*

*Is the debate indeed topical? Are we back in 1994 when Karl Lamers and Wolfgang Schäuble proposed the creation of a "Kerneuropa"? Is an institutional debate likely to reassure markets requiring immediate measures? As pointed out by President Van Rompuy<sup>1</sup>, markets' time isn't that of democracy. The first react instantly with a mouse's click on a computer while the democratic decision-making is based on a debate and a long process of conviction. Under these conditions, given the time required to adopt any amendment, the risk that the UK takes this opportunity to open discussions to regain some competences as well as the possibility of a referendum to be organized in some member states, is a long-term*

process. In addition, this is quite unsure that eurozone members would all share the same views. Indeed, the eurozone consists of a very heterogeneous whole and not all members have the same vision on how to manage monetary solidarity. The German Chancellor seems to assess it will be possible to find a new homogeneity among members of the eurozone by inserting a clause allowing the exit of the zone in the treaties. German and French visions are different. The French position seems largely based on an intergovernmental vision where the management of the eurozone would continue to be ensured in last resort by the Heads of State and Government. According to the position of the CDU, the strengthening of the zone should be built around common institutions: a Commission President elected by universal suffrage, a Commissioner in charge of the zone and a control by the Court of Justice. The debate between intergovernmentalism and integration will continue and is probably not ready to come off although surprisingly at the last Summit of the euro on 8 November 2011, members evoked a "further integration of the zone."

Beyond all forecasts, it has seemed essential to provide immediate answers. Despite the significant progress that has been made in the last two years, it appears that the governance of the zone is inadequate. The intergovernmental decision-making is weakly responsive and only little anticipatory. Given its hesitations and its delays combined with the need to wait for national parliamentary ratifications, this process hasn't always been able to respond in a timely manner. In addition to full-bottom measures (Eurobonds, interventions of the Central Bank to buy the debt, etc), it is deemed necessary to strengthen the governance of the zone. In this context, although it is necessary to take into account the views of the "outs", the decision legally belongs to the "ins." The Heads of State and Government have already taken action during their meeting in November 2011. In addition to the institutionalization of the eurozone summits chaired by Herman van Rompuy, the appointment of a permanent President is still pending. The Eurogroup, in charge of coordinating economic policies, will prepare summits and ensure their follow-up. It has not been decided yet whether its president, Jean-Claude Juncker's successor will be appointed among the members of the group, the Ministers of Economy and Finance, or will become a full-time President in Brussels. However, as for the Economic and Financial Committee, the working group "Eurogroup" will have a permanent president. Regular meetings will be held at least once a month between the eurozone summit President, the Commission President and the President of the Eurogroup, at the invitation of the President of the ECB. It was questioned if as for the High Representative for CFSP, the President of the Eurogroup could be the Commissioner for Economic and Monetary Affairs as well. However the Commission doesn't seem to be in favour of this. Finally, the communication, which was until now very erratic and gave rise to many problems in the markets, will be entrusted to the eurozone summit and Eurogroup Presidents. It remains to be seen whether the Heads of State and Government would follow this discipline. Probably not. This is basically the first rationalization of a structure that remains intergovernmental. It is not surprising since according to the treaties, economic policies come within coordination.

The discipline of the eurozone could have actually been ensured by decisions made on the basis of the Article 236 TFEU coming only from eurozone member states. France and Germany preferred the specific design but one should look how it could be based on the treaties. Merkel's favourite idea to entrust the control of fiscal discipline to the Court of Justice with a power of sanction has not received a warm welcome, except to check the implementation of the "golden rule" into national law. It is known that our German neighbours particularly cherished jurisdictional control. But does the Court have the technical expertise to perform such an activity, or should it better be entrusted to a more specialized authority, subject to a possible judicial review? Otherwise the Court's control would risk of being limited to apparent errors unless extremely precise criteria are established. Given the field's importance, parliamentary involvement is essential to ensure democratic control. Would the current situation, where democratic control is provided by national parliaments, last? Would another specific authority be created or would the European Parliament be used? The scope is narrow given the jurisprudence of the German Constitutional Court.

Could the next steps reach a gradual strengthening of the eurozone within the Europe of twenty-seven? According to J.C. Pirié, this strengthening could be emphasized by a systematic use of enhanced cooperation notably in fiscal and social policies as stipulated in the treaties, with possibly a switch to qualified majority voting on fiscal matters, one can dream. A more ambitious reform could take place only at a later stage. For now, differentiated integration seems to have gained advantage over a two-speed Europe. As it is often the case, with the threat of a group of seventeen set up, the other member states have chosen to join the Eurogroup rather than staying sidelines. But for how long would this situation last?

## **Introduction of a Member Institute: Finnish Institute of International Affairs**



The Finnish Institute of International Affairs is a Helsinki-based independent research institute that produces high level research to support political decision-making and public debate both nationally and internationally.

At the beginning of this year, a new programme structure was launched at FIIA for the period 2011-2013. The three research programmes are: the EU research programme (director Juha Jokela), the EU's Eastern Neighbourhood and Russia research programme (director Arkady Moshes) and the Global Security research programme (director Mika Aaltola). The programmes have three-year working programmes.

The European Union research programme focuses on the EU's global and regional role, including the internal dynamics of the Union. The main research themes are the EU's external action, economic policies and institutional development. EU's development policy will also be monitored more systematically in the future.

The EU's Eastern Neighbourhood and Russia research programme studies the EU's eastern environment with a special focus on Russia's domestic and foreign policy. In particular, the programme concentrates on political developments in the region, energy and climate policies. It also studies international relations in the EU's eastern neighbourhood and the relationship between the region and the EU. Like the recent Duma elections, the forthcoming presidential elections will be followed particularly closely.

The Global Security research programme approaches global security challenges within the framework of broad security. The programme seeks to understand the global trajectories of security that have significance for the European

and Finnish security environments. The issues approached include the prospects for global governance systems, changes in the major power structure, significant factors in functional and regional security and insecurity, the role of the transatlantic relationship in world politics, and the different dimensions of the European security policy. The programme's high level of expertise on Asia is reflected in a number of recent publications.

In addition, the Institute has several on-going projects which transcend the boundaries of the research programmes. For instance, the Institute has launched a peace mediation project in order to enhance debate, research and awareness of peace mediation in Finland. The project establishes cooperation networks and organises events which analyse the key questions relating to Finnish peace mediation capacity and tradition, the topical issues of peace mediation, peace mediation as part of Finnish foreign policy, and the role of small states in peace mediation. The project, which is conducted in close cooperation with the Crisis Management Initiative, brings together national and international researchers, experts and decision-makers in the field of peace mediation.

The Institute was established by the Parliament of Finland in its centennial plenum in June 2006 and the Parliament also provides the Institute's basic funding. The Institute is autonomous in its research activities and is governed by a nine-member board, assisted by an advisory council and a scientific advisory council. ### TEPSA Guest Lecture on “Is the EU becoming more intergovernmental?”

11 November 2011

Dr. Adriaan Schout, Clingendael Netherlands Institute of International Relations gave the lecture. He argued that it is essential to conceive the coherence and complementarity between national and EU's political systems rather than continue grand theoretical debates on whether the EU is evermore becoming a federation or, on the opposite, moving towards becoming more intergovernmental. Dr. Schout elaborated on the idea mainly employing the organizational management approach and giving examples (such as Catherine Ashton's EU foreign policy or the use of impact assessment in the EU institutions and member states) to illustrate his main suggestion that the strengthening of EU institutions does not conflict with but is rather closely related to and in the interest of member states.

### THESEUS Conference Which way forward? Three Years after Lehman, Two Years after Lisbon

The Euro crisis continues to be the biggest current and future challenge for the EU affecting almost every other field of EU policy-making outside of the European Monetary Union.

From 24 to 25 November 2011, the Jean Monnet Chair of Prof. Wessels (University of Cologne) successfully organized under the lead of Mirja Schroeder this year's THESEUS Conference at the Fritz-Thyssen-Stiftung in Cologne. The conference brought together academics and practitioners from across Europe to discuss current and future challenges of Europe. The renowned speakers analyzed questions regarding Franco-German leadership, if and how to solve the Euro crisis, the institutional balance within EU as well as the assessment of EU external action. Significantly, most of the discussions were influenced and driven by questions on the consequences of the Euro crisis. The conference ended with concluding remarks by Prof. Jacqué

One of the lectures was on the economic sanctions and the effect it had on children, and the current situation in Iraq. Additionally, Ingibjörg Sólrún Gísladóttir, former Minister for foreign affairs, talked about her work with a Palestinian/Israeli peace association consisting of Palestinian and Israeli women. The book and the lectures have received a lot of media attention and the book is on the bestseller list and has just recently been nominated for the book award in the academic field.

### Suzuki: We need to act now!



An environmentally conscious audience gathered at the University of Iceland to listen to Dr. David Suzuki, a world renowned documentary film maker, TV program director, environmentalist and former Professor at the University of British Columbia. Dr. Suzuki was the keynote speaker at an inspirational seminar hosted by the Reykjavík International Film Festival (RIFF), IIA and the Institute for Sustainability Studies. Dr. Suzuki addressed the question *What Can We Do?*, referring to the general public's and authorities' reluctance to respond and take proper environmental action, in spite of ample evidence of the urgency to do so. His expertise in the environmental field and his love for nature is very inspiring and it was an eye opening seminar as he discussed the importance of immediate action. His conclusion is that the human race needs to act now before we have to turn to desperate measures and it might even be too late.

This event was our first collaboration with RIFF and we hope to continue working with them in the future. Prior to his lecture, a documentary about Suzuki was shown, titled Force of Nature: The David Suzuki Movie.

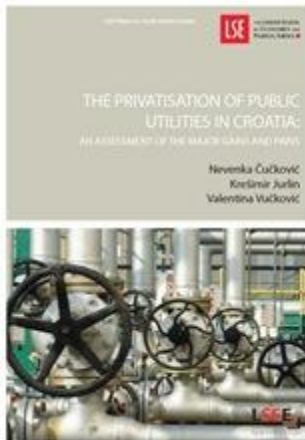
