News of TEPSA Secretariat

We are pleased to welcome two new members of the TEPSA team in Brussels: Benjamin Rey and Ingrid Bozin.



Benjamin Rey replaced Mathieu Briens, who left TEPSA to join the European Commission in January, as Research Assistant in March.

He studied at the Institute of Political Sciences in Toulouse (France) and holds a MA in EU International Relations and Diplomacy from the

College of Europe in Bruges.

He gained further experience of the EU at the European Parliament before joining TEPSA. His main areas of interest include the EU's relations with its Southern neighbours and with the Middle East. Benjamin speaks French, English, Spanish and Arabic.

Meeting of the Board 16 April 2008

On 16 April seven members of TEPSA's Board attended its latest meeting at the Fondation Universitaire, Brussels, under the chairmanship of Professor Wolfgang Wessels.

The Board discussed all aspects of TEPSA's activities, its situation and prospects, and latest developments in the TEPSA network.

The Board noted that the financial situation of TEPSA remains sound, and welcomed the two new personnel in TEPSA's secretariat (Benjamin Rey and Ingrid Bozin).

Among the matters discussed were:

- Progress with enlargement of TEPSA to include new member institutes, both in member states (Malta, Slovakia, Romania) and in prospective members.
- The preparation of TEPSA's Pre-Presidency Conference and General Assembly in Paris in June.
- The successful work conducted by TEPSA in preparing briefings for the European Parliament's Foreign Affairs Committee.
- The publication of TEPSA's new brochure, and plans for its new website.

The Board approved an action plan for TEPSA's Guest Lecture series (a new project announced at the last General Assembly) and further information will soon be sent to all member institutes.

After the Board's deliberations, the first meeting of the Steering Group of the TEPSA Training Programme developed ideas for this new project, on the basis of a paper prepared by Yvonne Nasshoven, Andreas Hoffmann and Benjamin Rey, taking account of positive comments received from many members of the TEPSA network.

Workshop: "The European Neighbourhood Policy: Challenges and Prospects"
Brussels, Fondation Universitaire, 4 April 2008

THESEUS

The project THESEUS is happy to welcome Prof. Dr. Anne-Marie Le Gloannec (Centre d'études et de recherches internationales CERI, Sciences Po Paris) as first **THESEUS Visiting Professor** at the Jean Monnet Chair for Political Science at the University of Cologne.

She holds a course on "Strategic and conceptual approaches: the EU in the international system". The objective of the chair is to reinforce cooperation in the field of European integration research and to foster transnational academic discourse in Europe. It addresses scholars with a focus on European integration.

From 1997-2002 Anne-Marie Le Gloannec was Vicedirector of the Marc Bloch Institute in Berlin. Beyond her teaching activities in France she was lecturer at the Europe Centre of the Johns Hopkins University in Bologna, at the Free University Berlin, at the Europe-University Viadrina in Frankfurt/Oder and at the University of Stuttgart. She published important works on international relations and the role of Germany in Europe.

Her inaugural lecture will take place end of May at the Institute for Political Science and European Studies of the University of Cologne.

On 30 April will take place the first **THESEUS** Lecture on "The review of EU Finances" by Prof. Dr. Jacques Le Cacheux (Observatoire français des conjonctures économiques OFCE, Sciences Po Paris) at the Institute for Political Science and European Studies of the University of Cologne.

From 29 June to 5 July will take place the next THESEUS Summer School in Brussels on "The EU's role in the world – what priorities?"

The EU's role on the international scene is controversial. The negotiations leading to the Lisbon Treaty highlighted this once again. With the incoming French presidency and the revision of the implementation of the European Security Strategy decided by the European Council in December 2007 the topic figures once again high on the EU agenda. The THESEUS Summer School will ask main

political decision-makers, civil servants and experts about current and future priorities for external action of the European Union - such as Gianni Bonvicini (Istituto Affari Internazionali, Rome), Geoffrey Edwards (Cambridge University), Gunilla Herolf (Stockholm International Peace Research Institute) or Elfriede Regelsberger (Institut für Europäische Politik).

The THESEUS Summer Schools look each year for 20 excellent young professionals and researchers to tackle together with speakers and high-level experts from international organisations, research, business, politics and NGOs one of the internal and external challenges which Europe faces. The full call for applications will be available on the THESEUS website (www.theseus-europe.net) in the coming weeks.

Last but not least, the THESEUS High Council selected the first **THESEUS Europe** and **Future Award** winners. The Europe Award is granted to a European having distinguished her or himself by a long-term transnational commitment for Europe. The two Future Awards are given to outstanding projects or works that deal constructively with the future challenges of Europe. The ceremony will take place in Cologne in June this year. EU CONSENT General Assembly in Paris

In the context of the TEPSA Pre-Presidency Conference "La France en Europe, un acteur pas comme les autres?" on 12 and 13 June 2008 in Paris, EU-CONSENT will hold a General Assembly entitled "Horizontal integration and network sustainability: EU-CONSENT's third annual reporting" prior to the commencement of the TEPSA event.

The Assembly will take place in Paris on Thursday 12th June 2008 from 12:00h to 13:00h at Maison Heinrich Heine (Cité Internationale Universitaire de Paris, 27c Bd. Jourdan, 75014 Paris).

Since the next EU-CONSENT plenary conference will not take place before March 2009 it was decided to hold an additional General Assembly during the calendar year 2008 in order to provide for continuous coherence of the network. The 3rd update of the Joint Programme of Activities will be presented, discussed and put to vote during the meeting.

Since EU-CONSENT is entering its final year, particular emphasis will be laid on the sustainability of network activities beyond the funding period. Participation is therefore warmly encouraged. A more detailed agenda to the General Assembly will be circulated beginning of May 2008.

Member of the Board of TEPSA & EU Programme Director at the Finnish Institute of International Affairs, interviewed by Benjamin Rey

You are very committed to TEPSA's activities. How did you get interested in the network and what are, in your opinion, its main benefits for you and the Finnish Institute for

International Affairs (FIIA) in Helsinki?

I remember that my first trip abroad as a researcher from the FIIA was to a TEPSA round table conference on the results of Amsterdam. That was back in the autumn of 1997 and I had only just started at the FIIA. I was really pleased to find again the European debate that I had left behind when leaving the European University Institute in Florence. Back in the 1990s, the debate – both as to topics and to style – was quite different in Finland from what it was in continental Europe. To some extent, this still holds true.

I think our institute has benefited from TEPSA membership both in terms of visibility as "the"

Finnish policy research institute on EU affairs and in of networking terms opportunities. The of organisation the two **TEPSA** Pre-Presidency conferences in Helsinki in 1999 and in 2006 was a chance to get a number of interesting, new people to Finland – and great fun, too!

In the future, I am looking forward to TEPSA's plans to help young researchers network among themselves and get policy research training that they would not get in the university world, perhaps not in most think-tanks, either.

Although your institute was established in 1961, it took on a new legal basis in 2007 in association with the Parliament of Finland. Was it a "second birth" and what does it concretely mean for your objectives and activities?

In a sense, yes, we were reborn. The most important change has come through a considerable

enlargement of our research staff. In May, when all the people we recruited last autumn have arrived, we'll be altogether 23 persons including researchers, research assistants and research programme directors. What I find great is that there are many different nationalities present. For years already, our working language has been English. Now, you occasionally also hear Russian, Chinese, Arabic, Spanish, Italian or French – and more – spoken in the corridors.

We have also reorganised our work in a new way. We have four research programmes and each researcher is part of one programme – even though she or he might also have projects in another programme. Through these small groups of some 6 persons, we combine team work with the perhaps more traditional individual research.

The EU foreign, security and defence policy is Finland's foreign policy priority. To what extent do you think Finland has managed to integrate

its own objectives in the development of CFSP and in the formulation of the EU's foreign policy choices?

Now, this is an intricate question! I think it is part of the Finnish EU 'credo' to say that Finland has contributed a lot and has had quite an impact on the CFSP. People like to refer to the Petersberg tasks as having been brought into the Amsterdam Treaty thanks to

Sweden and Finland. Other examples of questions where Finland has had some influence would include the EU's policy on Russia, emphasis on civilian crisis management, and regional questions – that is, the Northern Dimension, and in the near future probably the Baltic Sea. A strong CFSP has time and again been defined as being in Finland's interests.

In particular, Finland has been keen on keeping the member states united, impeding splits occurring among them in foreign and security policy issues. The Finnish influence might even be seen as paradoxical, since one could think that a non-aligned

country (if that term still can be used) would not be among the most active member states in CFSP. But herein also lies a partial answer: Finland has been active and constructive in order to dispel doubts about its ability and willingness to be a full CFSP member. The activism extends to the ESDP as well, to the Battle Groups and the European Defence Agency in particular – but common defence has been a question where the Finnish position seems to vacillate.

Until 2004, Finland was the only member state that had a border with Russia. Did the latest wave of enlargement have an impact on Finland's policy towards its giant neighbour?

There seem to be signs of a reconsideration of the benefits of bilateral relations. When Finland entered the EU, it was assumed that relations with Russia would henceforth be multilateral – and for many, this was very welcome. Now, the picture is less clear. Enlargement no doubt has increased the diversity of views on the EU-Russia relations within the EU and made it more difficult for

Finland to understand how exactly it should act, what strings to pull so as to influence – or build – that policy. As a result, the Finnish politicians seem again to value direct bilateral relations with Russia. But isn't this what all countries do? Well, that's the question: are bilateral relations undermining the very idea of the CFSP, or are they additional channels through which common policies can be implemented?

Having ratified the Constitutional Treaty, it did not seem at first sight that the ratification of the Lisbon Treaty by Finland would pose any major problem. But in March, the tiny Åland islands threatened to block the process in order to protest against the EU ban on snuff. What is your comment on this?

This is about more than snuff, really. The question is about the autonomy of the Åland islands and how the Finnish EU membership unintentionally impacts on it. In the view of the representatives of Åland, completely satisfactory settlements have not yet been found. Finland has come to represent the Åland islands in the EU not only in questions that normally falls under Finnish legislation, but also in questions that fall under the Åland islands home rule. On a more general level, the case leads to thinking about whether the EU should be more responsive to autonomous territories. How to ensure

that they are properly represented? It also brings the Åland islands to the fore in Finnish debate – where they seldom appear. And, for Åland, this is a question of finding the appropriate ways of getting understanding and attention, and constructive ways of contributing to the debate.

Let's end with a traditional question. We know that research is a full-time vocation; but do you have some time left for other activities?

It is true that research tends to be a vocation ... But there is always time for music – for the moment, as a Lusofile, I'm listening to Ronda dos Quatro Caminhos, and as a beginner in Turkish, to Ferhat Göcer. Languages and literature are very important in life, too!

Institute of International Relations, Prague

In January 2008, the Institute of International Relations (IIR) in Prague held a closed **round table** at the Ministry of Foreign Affairs with the Director of Directorate of the European Commission for the European Neighbourhood Policy Coordination **Mr. Rutger Wissels**.

In March 2008, IIR Prague organised, in cooperation with the Ukrainian Embassy, the conference "15 years of Diplomatic Relations between Czech Republic and Ukraine". The conference, which was

attended by almost a hundred participants, had two panels: 1) Political aspects of mutual relations and 2) Economical and cultural relationships.

On the 5th-6th June 2008, the conference "Visegrad Cooperation and the Czech EU Presidency", which IIR Prague is organising in cooperation with the Visegrad Fund, will take place. This conference resumes where the Budapest conference from December 2007 (The Foreign Policies of the Visegrad Countries towards the Eastern Neighbourhood – Areas and Options of Cooperation) left off. The Prague conference in June will focus on regional cooperation in Middle Europe during the presidency of Czech Republic in the European Council from 1 January 2009 till 1 July 2009. Institute of European Affairs, Dublin

In December 2007 Alan Dukes finished his term after five years as Director General of the Institute of European Affairs, and in March 2008 Jill Donoghue, Director of Research, was appointed Deputy Director General and acting Director General.

The 2007 survey of the 25 largest Slovenian multinational enterprises (MNEs), conducted by the Centre of International Relations (CIR), Ljubljana, and the Columbia Program on International Investment (CPII), New York, was released on February 18, reveals dynamic outward foreign direct investment (FDI) activity by Slovenian firms. FDI outflows from Slovenia have surpassed FDI inflows in three of the past four years, as Slovenia firms look to expand in foreign markets.

The principal findings of the survey are that, in 2006, Slovenia's Top 25 MNEs, valued by foreign assets, had US\$4bn¹ in assets abroad; had nearly US\$4bn in foreign sales (including exports); and employed 23,616 persons abroad. Their foreign assets and employment each more than doubled since 2004, while foreign sales increased 60%. Foreign assets are concentrated in Europe. The top three firms – Mercator, Gorenje, Krka – account for more than half of the total assets of the Top 25, and the top five firms account for 68% of the Top 25's total foreign assets.
