**Editorial:**

*Still one more effort, comrades...*

*The endless saga of the EU's accession to the European Convention of Human Rights<sup>1</sup> seemed to have come to an end. The expert group in charge of preparing a draft agreement seemed to have achieved its goals and had transmitted its text to the Steering Committee of Human Rights of the Council of Europe. Yet, the aforementioned Committee has faced some difficulties mainly coming from EU member states. Being unable to tackle them, the issue was transmitted to the Committee of Ministers of the Council of Europe. However, the United Kingdom holding the biannual presidency of the Committee of Ministers didn't seem eager to address the issue. Instead, the UK favored focusing on a reform of the Strasbourg Court in a narrower sense as part of a conference to be held in Brighton. It is true that at the Council of the EU thanks to the Commission, negotiations continue in order to cope with this issue.*

*However, the main obstacles that stood in the need to preserve the specificity of the EU's legal order seem to have been successfully overcome. The mechanism known as "codefendant" allows the Union or its member states to make a common cause for a case brought in front of the Strasbourg Court where it appears to be a link with EU law. The mechanism of prior involvement allows the Court of Justice of the Union to intervene before the Strasbourg Court pronounces itself, when it has not had the possibility to do so before a case was brought to Strasbourg. Certainly there will always be those who find these solutions imperfect, but overall, the compromise seems to be excellent.*

*Therefore what are the obstacles remaining and are they insurmountable? It seems that one of the problems comes from the participation of the Union in the Committee of Ministers when the latter is requested to pronounce itself on the follow-up of legal cases. In the context of the Union's legal cases, the proposal foresees that the decision can be taken by a majority or a two-third majority of non-EU member states of the Council of Europe. This solution had been chosen to reassure non EU-members states who feared the Union's cumulative voting, that it would not give the Union a predominant role. France and the UK are*

*opposed to this solution in which they see a precedent to the future participation of the Union in international organisations. The question is largely theoretical, since in most cases, decisions are adopted by consensus. One should be able to find a formulation suitable for all or, if necessary, decide that no-one should vote on its own case. This would solve the problem on the model of what is expected when the United Nations Security Council intervenes to tackle disputes peacefully.*

*Another concern appears to be linked to the status of the Common Foreign and Security Policy of the Union (CFSP). One knows that the EU Court isn't competent to pronounce itself on CFSP except for restrictive measures towards natural and moral persons. Yet, this restriction does not apply to the European Court of Human Rights. For this particular reason, there is an express willingness voiced to exclude CFSP from the control of Strasbourg. It is uncertain whether such exclusion would prove itself to be effective however. The Bosphorus jurisprudence could be applied to such measures in the context of an appeal against a member state. It would also be possible to refer a request against a group of member states to the Strasbourg Court. Under these conditions, would it not be better to give up the claim to exclude CFSP from the field of control of the European Court of Human Rights?*

*The accession has remained a main concern of the Union for many years. Yet, should it now remain frozen because of side issues while the most significant challenges are about to be overcome? Can the political will clearly expressed by the authors of the Lisbon Treaty be used against purely technical obstacles with a side interest? One more effort comrades and the old world of the Union's immunity towards the Strasbourg Court should in the end be behind us.*

## **Introduction of a Member Institute: Institut für Europäische Politik**



The Institut für Europäische Politik (IEP) has been active in the field of European integration since its foundation in 1959.

It is one of Germany's leading research institutes in the field of foreign and European policy and a founding member of TEPSA. In all its activities, IEP takes into consideration that the European Union is a complex construct of institutional collaboration and communication and that the policy areas to be dealt with relating to the European Union are diverse and offer a wide range of research topics and case studies to examine. The IEP is also a founding member of the Trans European Policy Studies Association (TEPSA) and has been a member of the European Movement Germany since 1962. The institute's activities can be characterized in a three pillar structure, namely "Research", "Forum" and "Training".

**Research:** In its research, IEP combines the discussion of current problems of European integration with an analysis of medium-term trends and scenarios of European politics and policies. It focuses on:

- the future of the European Union (EU) including current reform debates, and long-term trends of European integration,
- German European policy and Germany's role within Europe,
- Enlargement and the EU's policy towards its Neighbourhood emphasising possibilities and limitations of the EU to shape its relations with neighbouring countries and its capacity to influence transformation processes in its neighbourhood,
- the Common Foreign, Security and Defense Policy,
- as well as issues of a common approach to energy and climate issues.

**Forum:** Activities include national and international seminars, conferences, fora, study groups and public events (lectures and debates). For lunch

debates, which take place on a regular basis, experts and prominent guest speakers are invited to discuss current key issues with the general public. Moreover, the IEP is involved in bilateral and multilateral fora, namely the "German-Hungarian Forum", the "German-Italian Discussion Forum", the "Franco-German Dialogue", the "German-Nordic-Baltic Forum" and the "German-Romanian Forum". The results of IEP's research and analysis are made available to its target groups and multipliers (lecturers, professors, students, teachers of adult education, journalists, politicians, administration, NGOs) by various publications of periodicals, single- and multi-author books, internet publications, policy papers and a frequently published newsletter. "integration" is a quarterly journal which offers an interdisciplinary theory-based and policy-related forum for current issues of European integration. The "Jahrbuch der Europäischen Integration" annually documents and evaluates the European integration process since 1980. Also the series "Europäische Schriften" contributes to the discussion of current issues in the field of European integration.

**Training:** IEP's training activities aim at the active participation in European affairs. The principal focus lies on the cooperation with countries from Central, Eastern and South-Eastern European Europe. IEP offers trainings on administrative reform and EU approximation as well as the implementation of EU-acquis in candidate countries. Complementary to the training programs the IEP is involved in study programs, which offer Master courses for young professionals, special training programs for senior officials, diplomatic services, NGOs and civil society.

## Recent Events

### Centre d'études européennes Sciences Po Paris and TEPSA

#### Conference on the Arab Spring: managing tensions and crisis inside and outside the EU 15 March 2012

On Thursday 15 March 2012, the Trans European Policy Studies Association (TEPSA), Brussels, organised in collaboration with the Centre d'études européennes Sciences Po, Paris a conference on “**The Arab Spring: Managing Tensions and Crisis Inside and Outside the EU**” at the Fondation Universitaire, Brussels.

*Peter Frisch*, Senior Political Economist and International Relations Officer in the Maghreb

department of the European External Action Service stated several indicators as root causes of the uprising in the Arab world. He also discussed the conspicuous absence of al-Qaida in the revolution and how that organization seems to have lost influence in the Arab world. *Peter Frisch* ended his talk on what Europe/EEAS could do in the post-revolutionary period with 10 points.

TEPSA EXACT Marie Curie Researchers *Nicole Koenig* and *Marlene Gottwald* presented their policy papers. *Nicole Koenig* enhanced the EU’s response to the Libyan crisis against 4 themes of the CSDP (planning, rapid response instruments, internal coordination issues, and capability gaps) and proposed four recommendations regarding the development of the CSDP. Finally, *Marlene Gottwald* shared with the audience her views on the options of EU engagement in post-conflict Libya. After having developed the current EU’s actions regarding the reconstruction of Libya, she tackled the short, medium and long term challenges that Libya, and more broadly, the North African countries are facing. She ended with the EU’s involvement options in Libya stating that “the Union’s efforts must be guided by the general principles of multilateralism and local ownership”. **Seminar on the Reform of the Court of Justice of the European Union: Structural reforms and new patterns of management  
14 May 2012**

The reform of the Court of Justice of the European Union is a recurrent issue. Successive revisions of the Treaties and the Rules of Procedure reforms attempted over time to solve the problems posed by the gradual increase of the number of cases. Today the increasing number of members of the Tribunal is being considered. It seems that the time has come to resume discussions on this subject. It must be especially assessed whether structural reforms are the only possible answers. There has been little discussion on possible solutions for future reform of the management of the Court. The Seminar will be opened by *Marianne Dony*, President of the Institute and *Jean Paul Jacqué*, Secretary General of TEPSA. The works will be introduced by the presentations of Professors *Franklin Dehousse*, Judge of the Court, and *Jean-Victor Louis*, Honorary Member of the TEPSA Board. Comments will be provided by a panel of practitioners and professors notably *Jaap W. De Zwaan*, *George Vandersanden* and *Denis Waelbroek*.

After the discussion, *Bo Vesterdorf*, Former President of the Court will give the conclusions. The seminar addresses all academics, practitioners and students. **Pre-Presidency Conference in Cyprus  
The Cypriot EU Presidency 2012: Institutional consolidation and responding to new challenges  
14-15 June 2012**

The TEPSA Pre-Presidency Conference in Cyprus is organised by KIMEDE (Cyprus Institute of Mediterranean European and International

#### **New EP project**

TEPSA has been approached by the Policy Department Citizens' Rights and Constitutional Affairs at the European Parliament to apply for a tender to elaborate a study on *the Democratic Control in the Member states of the European Council and the Euro Zone Summits*.

Many TEPSA members were very enthusiasts and thus showed great interest in participating in this tender. It was decided to submit a joint-application "NPEC – National Parliaments and the European Council" led by Professor Wessels on behalf of TEPSA together with Professor Rozenberg at Notre Europe, Paris. The proposed application includes the pro-active participation of many experts from the TEPSA and the OPAL networks. The Evaluation Board at the European Parliament communicated at the end of March that the our joint-application has been selected to conduct the study.

The project is based on the statement that there is a rising gap within the European Union between executive governance and parliamentary control. The aim is to provide a comprehensive overview with a common questionnaire for the 27 Member States and also in-depth reports for 12 Member States investigating the question of the significance of the parliamentary control of the European Councils and of the "information gap" between governments and parliaments. A synthetic perspective will also be elaborated including policy recommendations.

The interim study shall be delivered on 13 September 2012 and the final study on 26 October 2012. In between a workshop with the experts for


the 12 Member States of in-depth reports and advisors would take place around September. The kick-off meeting will take place on 27 April 2012 at the Fondation Universitaire to discuss the way forward of the project.

### College of Europe (Natolin Campus)



#### New board members

Prof. [Georges Mink](#) has been appointed to the College of Europe board as of the Director of Studies of the European Interdisciplinary Studies Department (Natolin (Warsaw) Campus) since the beginning of January 2012. Beside this, Prof. Georges Mink is also the Director of Research at the Institut des Sciences Sociales et Politique (CNRS - France), Université de Paris X, Nanterre. He is a Sociologist and Political Scientist, specialising in Central and Eastern Europe. His research and publications are dedicated to political systems, the sociopolitical evolution of these regimes, the conversion of ex-communist elites in Central and Eastern Europe and the europeanisation of national political systems. Today, his research focuses on the question of transitional justice in EU countries.

#### Recruitment: Job Vacancy – Senior Research Fellows at the College of Europe

The College of Europe is seeking candidates for two full-time positions of senior research fellow, covering respectively the Eastern and the Southern dimension of the European Neighbourhood Policy, with an expected starting date of either 1 July or 1 September 2012. The two positions are part of the Chair of European Neighbourhood Policy recently established at the Natolin campus.

#### Requirements :

- a Ph.D. preferably in international relations, political science, law, economy or history;
- a keen interest for European Neighbourhood Policy;

- a proven track record of research and academic publications in the field of the European Neighbourhood Policy;
- an ability to engage in teamwork and to participate in the development of research projects;
- a very good command of English and French.

#### Tasks include:

- the pursuit of research activities focusing respectively on the Eastern and the Southern dimension of the European Neighbourhood Policy and leading to academic publications;
- the participation in the organisation of seminars, workshops and conferences in the framework of the Chair of European Neighbourhood Policy;

The conference is organised by The Nordic Forum for Security Policy (The Finnish Committee for European Security – STETE and OSSE-nätverket, The Swedish OSCE-network) in co-operation with local partners: Institute of International Relations and Political Science (IIRPS) of Vilnius University, and the Non-Governmental Organizations' Information and Support Centre (NISC). **The European Youth Forum / The League of Young Voters in Europe**



TEPSA has been approached lately by the European Youth Forum (Ms. Jennifer de Nijs) to request the TEPSA network to be involved in the following initiative:

The League of Young Voters (LYV) in Europe aims to tackle an ever decreasing youth

participation at the European Parliament elections by increasing not only the level of youth-related non-partisan information available about the European elections, but also to encourage political parties and candidates to directly target young people in their campaigns. In this sense, the European Youth Forum is looking for a wide range of support for the League of Young Voters in Europe, which can include, but is not limited to, expertise, funding and visibility. It is essential to provide a structure and platform for direct dialogue between political parties/candidates and young people (16-35) so that it can become clear what stake young people hold in elections. The larger the network of partners of the LYV, the more young people can be reached in order to motivate them to participate in European democratic life and ensure their voice is heard.

#### **Timeline of LYV activities**

**2012:** Creation of the LYV and setup of its governing structure; identification and establishment of formal partners; pilot phase during the parliamentary elections in Lithuania (October); development of a “brand” and the online platform; fundraising activities.

**Early 2013:** Final development of brand and online platform; consolidation of partner campaigns; preparation of launch event in mid 2013.

**Mid 2013:** Launch of the online platform and promotional event for the newly established organisation “The League of Young Voters”

**Mid 2013- Mid 2014:** The League campaigns for the EP Elections;

**Post-election:** Evaluation of results of the campaign and planning of next involvement in elections.

*Nicolai von Ondarza*, **Legitimacy without influence? National parliaments in decision processes regarding military EU and UN missions in comparison** – Book publication.

From a parliamentary point of view, multi-lateral military missions are particularly challenging. This study comparatively analyses parliamentary participation in decision-making processes to deploy troops in five selected EU member states and takes a closer look at differences of formal and informal parliamentary decisions. It argues that such missions are generally pre-decided by governments on a European level. Remarkably, the European Parliament belongs to the most active parliamentary actors in this field, even though it lacks real competences. However, these activities were not able to show an impact on the decisions taken. Based on the examples of UNIFIL and EUROR RF CONGO, the study shows that national parliaments dispose of additional, EU-specific instruments in the case of EU missions, not available to them regarding UN missions. On the basis of the Lisbon Treaty closer cooperation between the European Parliament and national parliaments in the area of EU security and defense policies is suggested.

## ***Open Consultations of the European Commission***

TEPSA would like to draw your attention to the following open consultation.

An open consultation has been voiced by the Directorate General of Justice of the European Commission on consultation on Gender imbalance in corporate boards in the EU.

The target group are Member States, business or industry organisations, individual companies, civil society organisations with an interest in gender and/or social issues, trade unions, equality bodies, and other organisations or individuals.

As set out in its Work Programme for 2012, the European Commission is considering a legislative initiative to improve the gender balance in the boards of companies listed on stock exchanges.

On the basis of the Progress Report "Women in economic decision-making in the EU" presented by Vice-President Viviane Reding on 5 March 2012, the Commission is launching a public consultation of stakeholders on possible measures in this context.

This consultation will feed into an assessment of possible EU-level measures to enhance female participation in economic decision-making, which
