#### **Editorial:**

### J.P Jacqué

Since the beginning of his mandate, the President of the European Council had pointed out that foreign policy is one of the fields the European Council would give priority to work on. He was determined to put fully into practice article 22 TEU which entrusts the European Council to determine the strategic objectives of the Union in the context of the CFSP to the same extent as Community external policies. The economic crisis had delayed the prioritisation of this matter. It has henceforth been done since the European Council of 16 September 2010. On this occasion, the Council has not only dealt with several issues of foreign relations such as China or the upcoming G20 Summits, it has also defined the principles that the President Van Rompuy summed up in his press conference:

- "1. This is the beginning of a process. This European Council is the first in a row dedicated to foreign policy.
- 2. Our key messages should be mandated by the European Quncil, prepared and implemented by the Foreign Affairs Council, the Commission and the High Representative.
- 3. Reciprocity is a key word, it is not a dirty word; one can also speak about "mutual interests"."

In its conclusions, the Council asks the High Representative, Lady Ashton, to evaluate the general perspectives of the relations with the main strategic partners and to present a first report by December 2010. President Van Rompuy asserted his wish that summits with EU partners should be better prepared and that the routine should be altered in order to target more specifically on "the accomplishment of EU objectives". President Van Rompuy is in charge of leading this reform.

The European Council has wished to take the lead to conduct foreign policy, with both the High Representative and the Commission being in charge of the implementation. Time will tell whether these intentions will stand the test of time, however the existence of a fixed President of the European Council representing the Union during summits is a guarantee of continuity.

Our next meetings in Budapest as well as discussions during our TEPSA Working Groups will be an opportunity to exchange our views on this new development.

### **EXACT**

On the first of October the Marie Curie Initial Training Network "Integrated Training Programme for Analysis, Assessment and Advice on EU's External Action and its Institutional Architecture" (EXACT) will start. EXACT aims at preparing 12 Early Stage Researchers (ESR) for professional and academic careers in universities as well as in the public and private sector in academically based consulting for policy makers. The training network focuses its research on major current and future challenges of the EU in the fields of Commercial Policy, Common Foreign and Security Policy, Common European Defence Policy and Development Cooperation. TEPSA is one of the partner institutions of the EXACT project. All 12 EXACT fellows will start with academic training at the University of Cologne. From March onwards three EXACT fellows will work at the TEPSA secretariat for a period of 8 months. In November

2011 three new EXACT fellows will join the TEPSA secretariat. During their stay at TEPSA the EXACT fellows will be fully part of the TEPSA team and work on different projects, organise events and publish research. We look forward to welcoming the first trio of EXACT fellows, who will be introduced in a TEPSA newsletter of 2011. You can already meet all 12 EXACT fellows during our Pre-Presidency Conference in Budapest, where they will be active as note takers. #### **LISBOAN**

Next to the EXACT project, TEPSA also received good news on another project this Summer, called LISBOAN - Linking Interdisciplinary Integration Studies by Broadening the

European Network (funded under the EU Lifelong Learning Programme). This project will also start in October 2010 and has a duration of three years. The project consists of 67 partners from 32 countries, including 16 TEPSA institutes and is coordinated by the Jean Monnet Chair University of Cologne of Professor Wessels.

The main activites of LISBOAN will be the following:

- Three annual conferences (including meetings of seven thematic working groups: The EU's Institutional Framework Post Lisbon; Economic and Financial Policy; Area for Freedom, Security and Justice; EU External Action; The Lisbon Treaty in historical perspective; legal assessment of the quasi-constitutional nature of the Lisbon Treaty; Integration and Governance Research after the Lisbon Treaty)
- One specialised workshop per thematic work package and four additional ones
- Annual awards for excellence in teaching and research
- Three PhD-schools
- A lecture series comprising three guest lectures per annum
- An annual report ("Lisbon Watch") with brief contributions from partner institutes

#### **Recent Events**

#### EP Hearing on Artic Issues

After the delivery of their briefing commissioned by the Foreign Affairs Committee of the European Parliament, both Ms. Neumann (not present) from the Stiftung Wissenschaft and Politik (SWP) and Dr. Valur Ingimundarson from the University of Iceland, have been invited by the European Parliament to present their paper to the Brussels audience on the 2nd September 2010. This hearing was a unique opportunity for the researchers to present their findings as well as introducing their member institute to the Brussels arena.

The hearing discussed "a Sustainable EU Policy for the High North" and was introduced by Gabriele Albertini, Chair of the Committee on Foreign Affairs. The researchers covered on one hand how the EU policies affect the High North, illustrated by the examples of climate change and environmental policies and fisheries policy and on the other hand described the geopolitics of Arctic resources. The Director of Ocean Futures in Oslo also took part to the hearing and presented the changes, challenges and chances for the Arctic region. The hearing was concluded by the Rapporteur for this issue, Michael Gahler.

The new issue of EU-27 Watch is now available on the new internet platform <a href="www.EU-27Watch.org">www.EU-27Watch.org</a>. The EU-27 Watch No. 9 gives an overview on the current national debates on European policy in the 27 EU member states and the 4 candidate countries.

Laid out in four segments, the platform provides the reader with a comparative introduction, a list of responses sorted by country, a list of responses sorted by question, and a timeline listing all major events in EU politics since 2004. All texts are available in HTML and PDF format. All back issues of the EU-27 Watch and the Enlargement/Agenda 2000-Watch are available as well.

The topics discussed in the EU-27 No. 9 are: the implementation of the Lisbon Treaty, enlargement

and the European Neighbourhood Policy, the financial crisis and economic policy, and climate and energy policy. A comparative introduction gives an overview of the debates in the 31 countries covered by the EU-27 Watch.

### Electronic Collection "SPES Policy Papers" launched

The electronic collection "SPES Policy Papers", published by the Institut für Europäische Politik, is dedicated to issues of current and future relevance to European foreign and security policy. Written by fellows of the Study Programme on European Security (SPES) for fellows from Central and Eastern Europe — conducted by IEP and supported by the Volkswagen Foundation — as well as researchers from IEP, the papers focus on four thematic clusters:

- The EU and Russia
- European Enlargement and Neighbourhood Policy
- The EU's civilian and military crisis management
- European energy policy and climate change policy

Against the background that the scientific debate on European foreign and security policy is often dominated by Western perspectives, this paper series stands out by providing a platform for alternative viewpoints that focus on external perceptions and assessments of EU policies, actions and discourses.

The first policy paper (to download <a href="https://example.com/here">here</a>) written by Iryna Solonenko attempts to explain to what extent the EU has had an impact on internal developments in Ukraine since the European Neighbourhood Policy (ENP) was launched in 2005. By tracing the resonance that this EU policy has had on different actors and processes, the paper challenges the dominant discourse about the failure of the ENP.

The Austrian Institute for International Affairs (oiip) is a research partner in an innovative and unique research project on the perceptions of Asia in the European Union. The ASEF (Asia-Europe Foundation) initiative is a timely opportunity for Asia and Europe to gauge their respective understanding of one another, through examining European public, media and opinion leader's attitudes, knowledge and perceptions of Asia.

The 'Asia in the Eyes of Europe' aims to specifically: produce scientifically valid feedback on the perceptions of Asia in Europe develop an extensive dataset of information for civil society, business, researchers, students, policy makers, media gatekeepers and a broad range of cross-sectoral stakeholders communicate core policy recommendations clearly to relevant policy makers and opinion leaders in major policy fields including Economics, Environment and Energy, Security, and other global challenges.

The methodological approach will phase the research to carry out a representative sample of 8 EU countries (Austria, Belgium, Denmark, France, Germany, Italy, Romania, United Kingdom) and will examine the perceptions of Asia in Europe in three distinct areas: public opinion, media, and opinion leaders.

### Seminar: the elections in Bosnia-Herzegovina 4 October 2010

DIIS continues *Lighthouse Europe*, a series of public debates on issues of strategic relevance for the foreign policy of the EU and of its member states. In relation to the general elections in Bosnia on 3 October, DIIS is hosting a seminar with the title: "The Future of Bosnia: Stability, Governance and Europe" with the participation of experts from Bosnian as well as Denmark.

Almost 15 years since the Dayton Agreement put an end to the civil war, the challenges facing the country remain enormous. Bosnia is deeply divided between its two entities and burdened by a convoluted public administration. In the recent years, reforms have stalled, leaving the country even further behind its neighbours on the path towards the European Union. As the international community loses influence on Bosnia, external factors such as Kosovo's independence put pressure on the unity of the state. The initial assumption that the "golden carrot" of EUmembership would trigger comprehensive reforms appears to be losing credibility, also due to the inconsistencies of EU policy.
