Call for Applications

Working Europe Seminar on EU Trade Policy

Brussels, 29 January - 02 February 2018

In the framework of the **PONT** (**Professional Training on EU Affairs**), co-funded by the ERASMUS+/Jean Monnet Programme, the Trans European Policy Studies Association (TEPSA) is organising its third '**Working Europe seminar**', a 5-day seminar at the heart of EU politics, in Brussels. The seminar will offer 20 Master students from different national and disciplinary backgrounds an opportunity to gain first-hand insights from researchers, EU practitioners and policymakers on the current top priorities and trends of EU policy and politics in the field of trade.

Why studying trade policy?

'Trade' is a substance matter serving as the basis of EU cooperation. It represents the core business of the **internal market** characterised by the so-called four fundamental freedoms: free movement of goods, persons, services and capital.

While access to the EU internal market is a key point in **trade talks** (EEA, Brexit, Switzerland), trade agreements have also acquired an increasing impact in the international arena in the form of international trade agreements (such as TTIP, CETA). Trade is nowadays strictly connected with many other policy areas of the EU, such as development cooperation or the EU external action (including human rights promotion), which makes it one of the most interesting and challenging fields to explore. It also has an impact on citizens' lives, as testified by the ongoing public discussion regarding the content and consequences of international trade agreements (e.g. with regard to safety standards, environmental impact or investment protection provisions).

Objective and impact of the seminar

The main objective of the seminar is to deepen the knowledge of Master students on **EU political processes** by providing them first-hand knowledge on the roles and functions of EU institutions in view of the priorities of the EU's strategic agenda including the **EU trade interests, challenges and possible developments**.

By attending this seminar, participants will be able to:

- Acquire and deepen their **knowledge** on EU politics in the field of trade, gaining valuable insights into the practicalities of **Brussels policy-making**.
- Meet high level **professionals** from EU institutions, academia, and NGOs
- Meet and exchange views with **students** from different disciplinary and national backgrounds from all over the EU and beyond.
- Improve their analytical and argumentative skills.
- Enhance their employability.

Dates, location and format of the seminar

The seminar is a 5-day event. It will be held in Brussels from **Monday 29 January to Friday 02 February.** Prior to the start of the programme, participants will be asked to read relevant literature and draft a written assignment that will be integrated in the training programme. Full participation to all elements of the programme is compulsory. Participants will receive a **certificate of attendance** on the final day of the programme.







The seminar will be devoted to meeting **practitioners** from several EU institutions, academia and NGOs involved in the field of trade policy. Consequently, students will get an overview of the different actors and interests involved in trade policy and the complexity of negotiating satisfactory solutions.

On the last day of the seminar, students will be asked to combine the theoretical and practical insights they gained during the week in a **simulation game on trade negotiations**. The simulation game will be assessed by experts and each student will receive an individual feedback on her/his performance. Students will thus be able to comprehend the complex character of EU negotiations and improve their argumentative skills.

The training seminar is organised by TEPSA and will be led by **Prof Jaap W. de Zwaan**, Emeritus Professor of European Union Law at Erasmus University Rotterdam and Secretary General of TEPSA.

Target group and application procedure

The PONT Seminar on EU Trade Policy is designed as an interdisciplinary seminar and is open for **20 outstanding Master students** in Law and Social Sciences (e.g. Political Science, European Studies, International Relations, Economics).

Participants will be selected by a review committee. To apply please send 1) your CV; 2) a motivation letter explaining your research focus and interest in the seminar to pont@tepsa.eu. Non-EU citizens are also encouraged to apply. Deadline for applications is 10 December 2017 (midnight).

The participation fee for the 5-day seminar amounts to € 200. This fee includes all training and documentation. Participants be reimbursed for their travel and accommodation costs up to € 250. After the selection decision has been communicated, participants will have 7 days to transfer the participation fee. Failure to do so in time will result in exclusion from the training.

About the PONT project

<u>PONT (Professional Training on EU Affairs)</u> is a project that aims at building a bridge connecting postgraduate students and young academics with EU practitioners, in order to improve their employability. The project takes place over three years.

PONT enhances teaching and training activities in selected policy fields, with the objective to give postgraduate students and young academics the opportunity to develop their professional skills and prepare them for taking up a job in public administration, the EU institutions, NGOs, academic institutions or think tanks across Europe. The two main branches of the project are the Working Europe seminars for students and the Career Skills Trainings for young professionals.
