**José Juan Ruiz** is the Chairman of the Elcano Royal Institute. He has been a member of its Scientific Council for a decade. An economist by training, he is a member of the Spanish Civil Service. He has held positions in the Ministry of the Economy and in the private sector, while more recently he was Chief Economist and Director of Research at the Inter-American Development Bank. He is currently a member of the Economic Affairs Advisory Council of the Spanish Government's First Deputy Prime Minister.



**Pol Morillas** is Director of CIDOB. He is a political scientist, holds a PhD in Politics, Policies and International Relations from the Universitat Autònoma de Barcelona (UAB) and a Master's (with distinction) in International Relations from the London School of Economics. He is also a member of the Board of Cercle d'Economia and of IBEI's Observatori de Política Exterior Europea (European Foreign Policy Observatory).



**Lucia Mokrá** is the Dean of the Faculty of Social and Economic Sciences at Comenius University in Bratislava, Slovakia. Her main research interests regard the wider concept of European citizenship, fundamental rights after the Lisbon Treaty, the principle of non-discrimination in EU law, humanitarian aid and development cooperation.



**Lucas González Ojeda** Acting Head of the Representation in Spain, European Commission. At the European Commission, he was previously Head of Media & Spokesperson in Spain and Senior Financial Economist. Previously, he worked at the Bank of Spain as Senior Bank Supervisor.

**Pau Marí Klose** has been deputy (MP) for the Socialist group in the Congress of Deputies since 2019. Currently, he is also the Chairman of the Foreign Affairs Committee in the Congress. Between 2018 and 2019, he served as High Commissioner against Child Poverty of the Spanish Government. He holds a PhD in Sociology from the UAM and has been Professor of Sociology at the University of Zaragoza.



**Alexander Stubb** is the Director of the School of Transnational Governance as of 1 May 2020. He has served as Prime Minister, Finance Minister, Foreign Minister, Trade and Europe Minister of Finland (2008-2016). He was a Member of the European Parliament from 2004 to 2008 and national parliament (2011-2017).



**Richard Youngs** is a Senior Fellow in the Democracy, Conflict, and Governance Program, based at Carnegie Europe. He works on EU foreign policy and on issues of international democracy. Youngs is also a professor of international relations at the University of Warwick. Prior to joining Carnegie in July 2013, he was the director of the European think tank FRIDE. He has held positions in the UK Foreign and Commonwealth Office and as an EU Marie Curie fellow. He was a senior fellow at the Transatlantic Academy in Washington, DC, from 2012 to 2013.

She works mainly on EU governance, policy and institutional developments in CFSP/CSDP, civilian crisis management, EU relations with the United Nations and the African Union.

**Rem Korteweg** is Senior Research Fellow at the Clingendael Institute. He works on Europe's strategic role in the world, with a specific focus on the intersection between foreign policy, trade and security issues. Among his current research interests are European trade & industrial policy, the consequences of the Ukraine war, UK-EU ties, and Europe's changing relations with global powers. Rem is also the coordinator of Clingendael's public outreach initiatives.



**Michele Chang** is Director of Transatlantic Affairs programme and Professor in the Department of European Political and Governance Studies at the College of Europe in Bruges. Prior to joining the College of Europe, she was a Fulbright fellow at the Centre for European Policy Studies in Brussels and Assistant Professor at Colgate University after having obtained her PhD at the University of California at San Diego.



Erik Jones is Director of the Robert Schuman Centre for Advanced Studies at the European University Institute. He is Professor of European Studies and International Political Economy at the Johns Hopkins School of Advanced International Studies. He is author of *The Politics of Economic and Monetary Union* (2002), *Economic Adjustment and Political Transformation in Small States* (2008), *Weary Policeman: American Power in an Age of Austerity* (2012), and *The Year the European Crisis Ended* (2014).



**Juan Moscoso del Prado** is Doctorate (PhD) in Economic and Business Sciences by the UAM. Master's in Economics, by the College of Europe, Bruges (Belgium). He also has an Economics Diploma by the University of Kent, Canterbury (UK). Senior fellow at Esade Geo and professor (Centro de Economía Global y Geopolítica de Esade) and Head of the Department of Technical Assistance to the General Secretariat and International Relations at the Economic and Social Council of Spain (CES).



**Miguel Otero-Iglesias** is Senior Analyst at the Elcano Royal Institute and Professor at IE School of Global and Public Affairs. He is also Research Associate at the EU-Asia Institute at ESSCA School of Management in France. Previously he was Assistant Professor in International Political Economy (IPE) at ESSCA in Paris, Adjunct Lecturer at Queen Elisabeth House at the University of Oxford, postdoctoral Research Fellow at LSE and Associate Lecturer at Oxford Brookes University, where he obtained his PhD in IPE.
