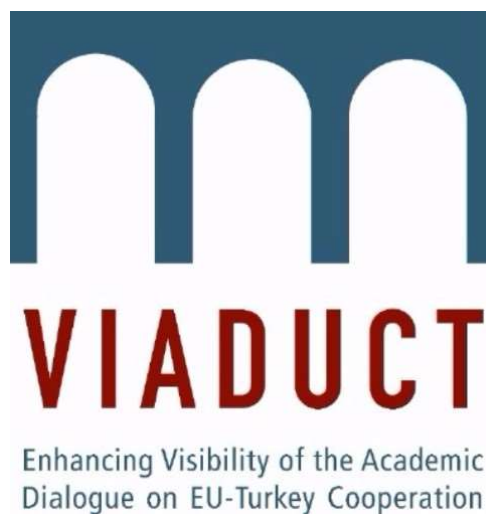

EDITORIAL

Which future for the EU-Turkey relationship? Domestic politics and external differentiation

membership is blocked. Both the Turkish and a majority of EU governments continue to have an interest in keeping up the appearances of accession negotiations to avoid the damage a clear break would entail. At the same time, the deepening of mutually beneficial economic and policy cooperation is held hostage by the politically motivated standstill in accession talks.

In this situation, **it seems like a smart idea to sidestep the politically and emotionally charged framework of EU membership and pursue a functional approach** towards institutionalized cooperation on individual policies. After all, the EU and Turkey are closely interrelated and interdependent neighbours with a joint interest in such diverse issues as trade, energy, security and migration – and they have been able to develop their policy-specific cooperation under the radar of the politicized relations and poisoned discourse at the highest political levels (Müftüler-Bac, 'Turkey's future with the European Union: an alternative model of differentiated integration', *Turkish Studies* 18(3): 416-438, 2017). Indeed, the EU has developed an ever more fine-grained web of differentiated integration with other non-member states, which either refused or were refused accession.

Yet despite its international and functional merits, **an intensification of EU-Turkey relations on the path of external differentiation would likely run into serious obstacles** – not only in the domestic politics of Turkey, but even more so in the domestic politics of the EU.

For one, the **increasing importance of the cultural dimension** in the party politics of European integration works against the deepening of EU-Turkey relations. At one end of the axis, right-wing populist parties have been on the rise. While these parties do not shy away from cooperation with authoritarian leaders and regimes such as Putin's Russia, for cultural reasons, Erdogan as a leader of a Muslim country does not benefit from their authoritarian sympathies. At the other end of the axis, liberal, green and left-wing parties, which used to support the gradual integration of a secular and democratizing Turkey against the culturally motivated opposition of the right, are appalled by Turkey's

appear to be functional, policy-specific and below the threshold of membership. First, deeper functional integration requires a more institutionalized and legalized relationship between the EU and Turkey and will necessarily be limited if one of the partners restricts the rule of law and the independence of the judiciary. Non-members with significant market access are typically countries with an excellent rule-of-law and regulatory record such as Norway or Switzerland.

Second, deeper functional integration will likely result in **mixed agreements, which require domestic ratification in the member states of the EU**. Domestic ratification multiplies the number of veto points, and it offers sceptics on the cultural left and right many opportunities to mobilize public opinion. The successful 2016 Dutch referendum against the Deep and Comprehensive Free Trade Agreement with Ukraine – an apparently functional and economic treaty without a membership promise – may serve as a warning of what might happen in the case of future differentiated integration with Turkey. The prospect of domestic mobilization alone will make mainstream EU governments shy away from negotiating functional agreements with Turkey that would require domestic ratification.

Finally, and partially as a response to Brexit, **the EU has become less generous and open with regard to external differentiation**. Not only the UK but also Switzerland have learned recently that the EU is adamant about protecting the integrity of the internal market and the primacy of EU law.

Rather than becoming a differentially integrated non-member state, Turkey is therefore likely to find itself in the company of Middle Eastern and Northern African (MENA) countries and confronted with the transactional deals between the EU and authoritarian non-members that are typical for this region. Arrangements like the EU-Turkey 'deal' on migration – and not institutionalized functional integration – may become the rule rather than the exception in the future relationship if the domestic politics of Turkey and the EU continue on their current trajectory.
